## Rotary Club of Memphis East MEMBERSHIP REQUIREMENTS

Shown below are the general qualifications regarding Rotary membership. Before submitting someone for membership, please read these provisions and make sure the proposed applicant satisfies the Rotary membership requirements. If in doubt, please contact Nina Gourley, (Chairman of the Membership Committee) or any member of the committee.

## **Section 1 -** General Qualifications

This club shall be composed of adult persons of good character and good business or professional reputation.

#### **Section 2 - Kinds**

This Rotary club shall have two kinds of membership, active and honorary.

#### **Section 3 -** *Active*

- .1 This club may elect to active membership a person who is
  - (i) engaged as proprietor partner, corporate officer or manager of any worthy, recognized business or profession; or
  - (ii) holding an important position in the executive capacity with discretionary authority in any worthy and recognized business or profession; or
  - (iii) acting as the local agent or branch representative of any worthy and recognized business or profession having charge of such agency or branch in an executive capacity, and
- .2 There shall not be more than one active member in each classification of business or profession excepting the religion, news media and diplomatic classifications and excepting the provision for additional active members as provided in the by-laws.
